General Art Show Rules & Regulations

Participation

1. All members of the Berea Fine Art Club are invited and encouraged to participate in this show. Non-members of the Berea Fine Arts Club will be juried before acceptance into this show.
2. Artists are to sell only items that they have created.
3. No selling of store bought items will be permitted, nor items assembled from kits or Xerox copies.

Submission:

4. The Berea Fine Art Club Jury Committee will review all applications.
5. Northcoast Promotions will present all applications submitted to the Committee for jury process of both members & non-members.
6. Deadlines: Members are to submit paperwork to Northcoast Promotions. Enclosed checks are to be made out to the BEREA FINE ARTS CLUB.
7. Members are guaranteed space up until 2 months before the event. After that date, if event is full, members will be placed on a waiting list for the event requested.

Notification:

8. Artists who enclose a self addressed, stamped envelope with enough postage will be notified by mail. All others will be notified by e-mail with materials for the event. All submissions will receive notification of status with the show, flyers & maps to this event. The BFAC will jury submitted applications the first Monday of each month.
9. Last notifications will be one month prior to the event(s) requested as to their acceptance or denial into the event(s).

Payments

10. Payments are due with submissions.
11. Exhibitors will be accepted until the last jury for the event.
12. Refunds or show credits will *not* be granted once booth fees have been accepted and deposited.

Taxes & Insurance

13. Sales tax is the responsibility of the artist.
14. Artists may be required to present Vendor’s Licenses.

15. Artists are responsible for acquiring the necessary insurance for damage and theft.

Displays

16. Artists are to display in a professional manner
17. Artists should provide appropriate boxes/bags for customers to carry purchased artwork.

Set Up & Space

18. Exhibitors are responsible for providing their own booths, tables, chairs and other props unless indicated otherwise on this form.
19. Exhibitors are asked to keep their area clean of debris.

Raffles

20. Donation to the BFAC raffle is mandatory. Raffle Donations are not tax deductible.

Tear Down

21. Exhibitors are responsible for removing unsold merchandise at the close of business on day(s) or participation.
